Ward Councillors D. Smalley and S. Waudby provided the following report:

- The Afghan Citizens Resettlement Programme is underway and will look to accommodate around fifty people in total, or ten families within the York area, over the next five years. Central Government will support rental costs, and City of York Council alongside local charities stand ready to support incoming refugees.
- The Environment Agency is continuing to work at Shipton Road and there are traffic cones in place to ensure the safety of workmen whilst an entrance to the site is created.
- The CYC planning enforcement team are investigating a complaint about a property in the parish.
- The Clifton library consultation has now closed – many thanks to all residents who submitted a response. Explore Libraries will outline what the next steps are soon.

This is to be considered by the RRA before any action by TIER is undertaken.
